ITU PARATRIATHLON EVENTS 2017

This document outlines the bid conditions for International Triathlon Union (ITU) Paratriathlon events:

- ITU World Paratriathlon Series (WPS)
- ITU World Paratriathlon World Cup (WPWC)

The World Triathlon Series Grand Final (hosting the Paratriathlon World Championships) and the Continental Championships where the staging of the Paratriathlon competitions are already a contractual obligation are excluded from this bid provisions.

1. General Information:

- a. ITU WPS and WPWC competitions are conducted by ITU in cooperation with its member NFs.
- b. ITU calls for bids annually, but multi-year agreements can be agreed upon.
- c. Priority will be given to existing organizers that host ITU events and/or followed the ideal development path of hosting a National event first.

2. Number of events per continent:

2.1 WPS competitions:

2-4 events Worldwide that can be combined with a World Triathlon Series event or ran independently, maximum 1 per continent.

2.2 WPWC competitions

- a. Europe: 4-6
- b. Americas: 2-4
- c. Asia: 1-3
- d. Oceania: 1-2
- e. Africa: 1-2

3. Event fee:

- a. The event fee is set at:
 - i. 5,000 USD for WPS races payable to ITU.
 - ii. 2,500 USD for WPWC races payable to ITU.
- b. Athlete registration Fee: The events will not be able to charge entry fee for athlete registration.

4. Classification:

- a. ITU will strategically target events for classification opportunities and in those cases will cover the cost of the classifiers and LOCs are expected to work closely with ITU to ensure classification requirements are met for facilities and established procedures in the regulations and to cover the accommodation of the classifiers from one day before classification to one day after competition finishes.
- b. LOCs can also request for classification opportunities outside of these events for both physical and vision impairments. For this the LOC is to pay ITU 3,500 USD per panel and all travel and per-diem costs of the classifiers will be paid by ITU. The accommodation of the classifiers is still the responsibility of the LOC from one day before classification to one day after competition finishes.
- c. Classifications hosted outside the official opportunities in the calendar will not be recognized by ITU.

5. General Requirements:

- Run the competition under the ITU Competition Rules and according to the LOC Requirement document and the Event Organisers Manual - EOM: http://www.triathlon.org/about/downloads/category/event_organisers_manual
- Events not being hosted together with another ITU sanctioned event must comply with and refer to the LOC Requirements document posted under http://www.triathlon.org/uploads/docs/
- c. Have previous experience in hosting national or international paratriathlon event.
- d. Minimum of:
 - i. 8 in-competition anti-doping control urine tests in total for WPS events
 - ii. 4 in-competition anti-doping control urine tests in total for WPWC events.
- e. Cover up to 15 room nights for the ITU team (distribution may be single/double rooms) for the WPS and 12 room nights for the WPWC.
- f. An event insurance of 5,000,000 USD is required unless the event is covered by the insurance policy of the existing ITU event.
- g. The event has to be supported/endorsed by the host National Federation.
- h. Live Timing and Tracking To be covered by the LOC
- i. Feed to the TV crew and live streaming on the ITU website.
- j. Max 90 USD Entry Fee
- k. Maximize exposure for the ITU title sponsor according to Branding Guidelines for Paratriathlon. Space for booth in expo area.

6. ITU Global Sponsor Activation

a. ITU reserves the right to activate a global sponsor for the events. The activation may include being the title sponsor.

7. Bidding timeline:

- a. Bid document released: 23 Sept 2016
- b. Submission of the Expression of interest: 21 October 2016
- c. 2017 ITU Paratriathlon Calendar announcement: 04 November 2016
- 8. The bids to be submitted to ITU at events@triathlon.org

Interested Host Organizers <u>must submit</u> the <u>APPENDIX</u> attached below to this document as part of their bid expression of interest along with a letter of host <u>National Federation support</u> and a letter of <u>support from the Host City</u>. The Paratriathlon World Ranking system will be reviewed by the ITU Technical Committee later this year and will consider the WPS events scoring between the World Championships and the Continental Championships, and the WPWC events below the Continental Championships.
